

JLG Crews Across America Sweepstakes

Official Rules of Play

1. OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY (EXCLUDING NEW YORK, FLORIDA, AND RHODE ISLAND), AND WILL BE GOVERNED BY U.S. LAW AND VOID WHERE PROHIBITED BY LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND NOT LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. NOT OPEN TO THE GENERAL PUBLIC (SEE ELIGIBILITY REQUIREMENTS IN RULE 2).

2. ELIGIBILITY: Sweepstakes entrants must be a legal resident of the fifty (50) United States or the District of Columbia, and eighteen (18) years of age or older as of January 1, 2019 (each such person is referred to as a "Participant"). Employees, officers and directors of JLG Industries, Inc. ("Sponsor"), its parent, subsidiaries, divisions, affiliates, suppliers, printers, distributors and advertising, promotional and judging agencies, (and their respective dependents, immediate family members [parents, children, siblings and spouse]) and individuals residing in their same household (whether or not related) are not eligible to participate in or win the JLG Crews Across America Promotion ("Sweepstakes"). Participant must be employed by a construction or related company completing aerial or site preparation, and upon entering the sweepstakes, are representing their official company. Limit of one (1) entry per person, per crew, per day. Entries that are illegible, incomplete, inaccurate or invalid are void. Duplicate entries submitted or received by the same Participant on the same day are void.

3. TIMING: Entry for the Sweepstakes will start January 1, 2019 at 12:00:00 am CT and end on September 30, 2019 at 11:59:59 p.m. CT (the "Sweepstakes Entry Period").

4. TO PARTICIPATE IN THE SWEEPSTAKES:

(A) How to Enter: To enter the Sweepstakes, visit Chooseyourcrew.com and complete the 'Nominate Your Crew' form. Entering requires the provision of the Participant's name, company name, job title, crew size and email address. All eligible entries must be received by 11:59:59 p.m. CT by September 30, 2019. You may also submit your entry by mailing the information in writing to: JLG Crews Across America Promotion Sweepstakes, c/o Swanson Russell, 14301 FNB Parkway, Suite 312, Omaha, NE 68154. All entries submitted become the property of Sponsor. No automatic, programmed, robotic, or similar means of entry are permitted.

i. Submissions must be family-friendly, and must not contain unsafe behavior or situations, profanity, nudity, pornographic images, explicit sexual themes, graphic violence, disparaging, hateful, racist, defamatory, slanderous or libelous statements or material considered illegal or immoral.

ii. Submissions may not contain an advertisement or a solicitation of any business or product.

iv. Sponsor is not responsible for any expenses incurred in the production and delivery of any entries/submissions.

v. Participants agree to and understand that submissions (including comments) may be made available to the public, including but not limited to posting on the internet. Whether or not submissions are published on the internet, Sponsor does not guarantee any confidentiality of any submission.

vi. By submitting an entry, the Participant agrees to grant and assign to Sponsor all intellectual property rights in the submission and each of its constituent parts, which rights include, without limitation, all right, title and interest in the copyright, including the right to apply for copyright and obtain registration in the name of the Sponsor, the Sponsor's

right to publish, use, adapt, edit and/or modify any submission in any way, make available to the public and/or reproduce the submission through any media without limitation, for commercial or non-commercial use, and without additional consideration to the Participant. In addition, Participant warrants that any so called "moral rights" in the submission have been waived and Participant acknowledges and agrees that Sponsor may use any ideas from any submission or other submitted materials, whether or not Participant has been awarded a prize in connection with any such submission or other materials.

vii. Any entry that does not comply with the above restrictions or any other requirement specified herein is subject to disqualification. In the event of disqualification, the associated entry will not be accepted for the Sweepstakes nor will the person submitting the entry be entered into the Sweepstakes. Furthermore, Sponsor reserves the right at its sole discretion to decline any submission for the Sweepstakes for any reason.

5. SWEEPSTAKES PRIZES: During the months of January, February, March, April, May, June, July, August and September 2019 (total of nine months), two (2) winners will be selected on behalf of the companies they represent each month. The first name drawn will win the catered lunch and JLG merchandise – estimated total value based on a crew size of thirty (30) is \$1,065 (the "First Prize"). The second name selected will win JLG merchandise – estimated total value based on a crew size of thirty (30) is \$615 (the "Second Prize", and collectively, the "Prizes"). Taxes are the sole responsibility of the winning companies.

(A) Odds of winning depend on the number of eligible entries received.

6. WINNERS SELECTION

Administrator (Swanson Russell) or an independent judging agency will select two (2) entries each month for the Sweepstakes Prizes described in Section 5 in a random drawing of all valid entries received. On, or about, the 5th of each month, Administrator will randomly select winners from all eligible entries received prior to the end of the preceding month. Winners will be notified by email. Winner must claim Prize within one (1) week of receipt of email or an alternate winner will be selected. Once contacted, administrator will request address for verification and proof of winning will be sent via certified letter. There will be total of eighteen (18) Sweepstakes Prizes. The winning Participants will be awarded the Prize, subject to verification of eligibility and compliance with all of the terms of these rules, including, at the Sponsor's sole discretion, the proper completion of tax-related documents (e.g., W-9). Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Winners will receive the First Prize, or the Second Prize, by the 30th of the following month after selected. Limit of one (1) prize per company for the Sweepstakes.

7. OTHER TERMS AND CONDITIONS: Participants in the Sweepstakes must comply with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements, the determination of which is at Sponsor's sole discretion. Participants agree to be bound by these rules. Sponsor has no obligation for reimbursement or replacement of any Prize. Prizes are nontransferable and must be accepted as awarded. Winner is responsible for any damage or loss associated with the use or enjoyment of the Prize. No substitution of the Prize is permitted except by Sponsor, who reserves the right to substitute a Prize of equal or greater value if the stated Prize is unavailable. No cash equivalent is available. All/any taxes, fees and surcharges on Prize is the sole responsibility of winner. Winner is responsible for all expenses associated with Prizes, including any costs incurred in claiming or using the Prize. Means of delivery of Prizes is at Sponsor's sole discretion. By accepting the prize, the winner agrees, and consents to the Sponsor's (and those acting under Sponsor's authority) use and posting of the winner's name, picture/portrait, likeness, voice and/or any/all submitted materials for advertising and promotional purposes without limitation, further consideration, or further compensation except where prohibited by law. Sweepstakes subject to all applicable federal, state and local laws, and void where prohibited.

If for any reason the Sweepstakes is not capable of running as planned, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure, human error or any other causes beyond the control of

Sponsor that corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsor is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any entry to be received by Sponsor due to technical problems or traffic congestion on the internet or at any website, any combination thereof, or otherwise, including any injury or damage to Participant's or any other person's computer (including hardware and/or software) related to or resulting from participation, uploading or downloading any materials in the Sweepstakes. Sponsor is not responsible for late, lost, damaged, illegible, incomplete, stolen, or misdirected entries. CAUTION: ANY ATTEMPT BY AN PARTICIPANT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

PRIVACY: Personal information collected from Sweepstakes participants will be used by Sponsor for the purpose of administering the Sweepstakes and may also be used to provide participants with information relating to products, services and promotions of Sponsor. Sponsor will not sell, share or otherwise disclose personal information of participants with third parties, other than to third parties engaged by Sponsor to fulfill the above purposes. DISPUTES: Each participant agrees that: (1) any and all disputes, claims and causes of action arising out of or in connection with this Sweepstakes, or any Prize awarded, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) UNDER NO CIRCUMSTANCES WILL A PARTICIPANT BE PERMITTED TO OBTAIN AWARDS FOR, AND EACH PARTICIPANT HEREBY WAIVES ALL RIGHTS TO, CLAIM PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES, ANY OTHER DAMAGES OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES, AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED.
